4. Proof of project/program completion is required by the end of the school year for which the grant is requested for. The teacher(s) should also make arrangement with CEC for a documentation opportunity. Proof of completion can be through photographs or visits by CEC employees and trustees.
5. **Grants are not intended for equipment or capital investments** (ex: iPads, tablets, computers, printers, projectors, playgrounds) unless the equipment is used in conjunction with a creative initiative.
